SECTION TWO SUITE POLICIES & PREFERRED VENDORS

Signage and Decorations

Suite Holders are not permitted to attach or display any signs, advertisements, notices, logos or other banners in or around the Suite – including inside and outside of doors – without prior approval from your Las Vegas Motor Speedway Sales Representative.

If LVMS grants permission to attach or display any of the above-mentioned items, the Suite Holder is responsible for the removal of said items prior to leaving the property following the event. The Suite Holder will also be responsible for any damages incurred to surfaces where signage or decorations were displayed.

Certificate of Insurance

All Suite Holders must have a Certificate of Insurance (COI) on file prior to entering the event suite. Please provide a copy of your COI to your Sales Representative prior to race weekend. An example of this certificate can be found at the back of this guide.

SECTION THREE TICKETS & ACCESS

Tickets

Suite tickets are printed tickets and will be mailed or delivered to you by your Las Vegas Motor Speedway Sales Representative. If you have issues with your tickets please contact your Sales Representative. Make sure your suite tickets are displayed at all times while at the track.

Entry Gates

All suite guests are permitted to enter via any open ticket gate.

Suite Check-In Process

All suites are located above the main grandstand seating area (above Section 2). Please stop by the Suite Check-In areas located outside Elevators 3 or 6. Suite passes will be punched and guests will receive a suite access wristband. Once you have your suite wristband, you may enter the suite level via one of the multiple grandstand elevators. Suite Check-In areas will open daily at the same time as ticket gates. They will close with 75 laps remaining in each race.

Gate Re-Entry

Re-entry is permitted on multi-day events. Please remember that your ticket must be scanned when exiting and upon re-entry.

Infield Access

Suite guests are permitted in the Neon Garage before, during and after the race each day. Please note, each day's Victory Lane will take place in the Neon Garage and all suite guests are welcome to attend. For those wishing to attend, we recommend heading down with 50 laps remaining in each race. To access the Neon Garage from Suite Level, take the Pedestrian Tunnel located under the Main Grandstands between Elevator Towers 4 and 5 to the infield.

Pre-Race Track Pass

Sunday Suite Passes also grant guests access to the pre-race activities happening on the stage prior to the start of the South Point 400. Stand on the racing surface and see the pre-race concert, driver introductions, presentations and VIPs. Fans also have access to the Drivers' Red Carpet for autograph opportunities as they walk out through the infield to the pre-race stage! Entering through the Neon Garage is the easiest point of access for Suite Guests.

Roof Access

Suite guests with roof access stickers are permitted on the suite roof. Please make sure your credentials are visible while accessing the roof.

SECTION THREE TICKETS & ACCESS (CONT.)

NASCAR VIP Pass

Guests with a NASCAR-issued VIP Pass will have access to the NASCAR Cup Series and NASCAR Xfinity Series garage (depending on the pass issued) during the designated times listed below. Access for minors with this pass will be restricted from the garages 30 minutes prior to on-track sessions.



SECTION FOUR GENERAL EVENT INFORMATION

Food and Beverage Service

All food and beverage must be ordered directly from the Levy Restaurants suite menu. Two Victory Lane Lounges, where guests can purchase additional alcoholic and non-alcoholic beverages, will be located on the suite levels. Victory Lane Lounges are located in Suites 111 and 236.

Please note you may not bring any food or beverages through the gates, up the elevators, or into your suite. There will be no exceptions.

Suite Temperature Control

The temperature of your suite is controlled remotely. Should you need a temperature change throughout the weekend, please contact 702-632-8100. Have your suite number ready when making the request to change the thermostat setting.

Security

You must pass through security checkpoints to access your suite. All guests will be required to have their bags searched (see 'Permitted Items' on page 8). Please have your suite ticket visible and ready for scanning during entry.

Fan Zone

Visit sponsor displays, see driver apperances, and shop for souvenirs in our Fan Zone located outside the main ticket gates.

Advertising

Speedway management reserves the right to approve all banners, signs and flags. No decorations or advertising is permitted on individual suite doors.

Parking

All suite guests will park in the Lot 4 Premium VIP Parking Lot (see map on page 10). Please be prepared to show your parking pass to the lot attendant for access.

ADA/Disabled Parking

- Display ADA/disabled placard in lower driver's side corner of the front windshield.
- Guests desiring to park in the Handicapped Lot in Lot 7 must arrive at the speedway via Interstate 15.
- From Interstate 15, take Exit 54 (Speedway Blvd.)
- From Exit 54 going toward the speedway, turn left adjacent to the LVMS marquee (shortly after exiting)
- Follow security's direction toward the Handicapped Parking Lot in Lot 7.

SECTION FOUR GENERAL EVENT INFORMATION (CONT.)

Smoking

Smoking is **NOT** permitted inside any suite at LVMS. Guests wishing to smoke may do so outside of the suite on the suite-level walkway. Guests are reminded to utilize the ashtrays located outside of suite doors. Throwing cigarette butts over the suite-level railing will not be tolerated.

Animals

NO animals — with the exception of service animals — are permitted in the suites or allowed through the ticket gates.



SECTION FIVE TRACK POLICIES

Permitted Items

- A maximum of two bags per person are permitted through the ticket gates. Clear bags are recommended but
 not required. Fans are encouraged to bring their personal items in clear bags no larger than 18x18x14 inches.
 A 'clear-bag express line' will be available at the ticket gates for quicker screening of people who use clear bags.
- Fans are permitted to bring items in non-clear bags such as backpacks or tote bags as long as those bags are no larger than 18x18x14 inches. All bags will be inspected upon entry.

Prohibited Items

- Aerosol cans (with the exception of sunscreen, sun block, hand sanitizer and bug spray)
- Alcoholic beverages (not permitted to enter or exit the gates)
- Any bag larger than 18x18x14 inches
- Any firearm or illegal weapons
- Collapsible chairs
- Confederate Flags (includes all RV lots and parking areas)
- Coolers
- Dry Ice
- Drones or any type of radio-controlled flying device
- Fireworks
- Folding chairs
- Frisbees, balloons, beach balls, footballs, or any other projectile sports-balls, etc.
- Glass or ceramic containers
- Golf carts, hoverboards, quads, UTVs, SxS, scooters, skateboards, Segways, dirt bikes or any other similar personal transportation devices (including licensed vehicles that may be street-legal)
- Illegal drugs/substances of any kind
- Knives longer than 3 inches in length when closed or longer than 6 inches in length when open
- Laser pointers, noise-makers, air-horns
- Monopods, tripods and selfie-sticks
- Obscene or indecent clothing
- Pets (except for service animals)
- Seat cushions with armrests
- Stadium seats wider than 18 inches or with arms
- Umbrellas
- Wagons that are not collapsible
- Any items which pose a safety hazard or can diminish the enjoyment of the event by other guests


Arrival via I-15 North:




I-15, Exit 54: Exit I-15 northbound at Exit 54 (Speedway Blvd.).


